3 the Teachers' Retirement System board meeting.
4 Today is February 27, 2020.
5 Mr. McTigue, will you call the roll,
6 please?
7 MR. McTIGUE: Thank you.
8 John Adler?
9 MR. ADLER: I am here.
10 MR. McTIGUE: Thomas Brown?
11 MR. BROWN: Here.
12 MR. McTIGUE: Natalie Green-Giles?
13 MS. GREEN-GILES: Here.
14 MR. McTIGUE: David Kazansky? Russell
15 Buckley?
16 MR. BUCKLEY: Here.
17 MR. McTIGUE: Debra Penny?
18 MS. PENNY: Here.
19 MR. McTIGUE: John Dorsa?

21 MR. McTIGUE: We have a quorum.
22 MS. PENNY: Thank you so much. Okay,
23 next we will go to the update on TRS
24 operations. Kavita Kanwar?
25 MS. KANWAR: TRS e-mailed eligible

2 members of UFT, CSA, and PSC and provided them
3 the opportunity to increase their TDA
4 contribution rate ahead of the retroactive
5 payments made under their union contracts.
6 The retroactive payments gave members a rare
7 chance to make a large one-time deposit into
8 their TDA account. Overall, nearly 12,000
9 members or 10 percent of the participants
10 increased their TDA contribution rate ahead of
11 the retroactive payments made under the union
12 contract.
13 TRS Member Education Team has kicked off
14 its outreach efforts for 2020. First, they
15 have scheduled 15 preretirement programs for
16 the spring, and during February over 200
17 members have already attended an inhouse
18 program. Also on February 8th, the Member
19 Education Team represented TRS at the Annual
20 Convention of the Elementary School Principals
21 Association.
22 Outreach for March includes events with
23 the Middle School Principals Association, CUNY
24 staff and campuses, and the annual UFT
25 Paraprofessional Festival on March 16th.

3 MR. BROWN: Will you be able to send us

4 that electronically?

5 MS. PENNY: Thank you so much. Okay,
6 great. Next we have a report from the
7 actuary, Ms. Sherry Chan.

8 MS. CHAN: Thank you, Ms. Chair. There
9 are two fiscal notes and believe it or not,
10 the legislative session is obviously underway
11 and they have moved up the legislative session
12 to accommodate the primaries so the fiscal
13 notes have fallen through. So there is two
14 that pertains to TRS that was issued since the
15 legislative session began.

16 The first one has to do with the basket
17 clause that we had talked about. This board
18 had voted on to increase the foreign equity
19 securities cap from 10 percent to 20 percent.
20 So the bill was drafted and fiscal note was
21 completed. There is no cost for that
22 legislative bill if it was to be passed. And
23 the second fiscal note has to do with the
24 retiree Ms. Cynthia Falletta who is currently
25 a Tier 4 retiree. And the legislative bill

2 would have her be reclassified as Tier 1 and
3 have her pension benefit recalculated. So the
4 increase is about 16,000 dollars or so on an
5 annual basis, and on the present value it
6 would be 318,000 total and because she is
7 retired, that would be if the legislative bill
8 was passed that 318,000 would be reflected all
9 at one time in one contribution immediately.

10 MS. PENNY: Thank you. Okay. Executive
11 director's report given by Thad McTigue.

12 MR. McTIGUE: Thank you. It has been
13 suggested that the next regular meeting of the
14 Teachers' Retirement Board be held on the
15 third Thursday of the month, March 19, 2020.
16 Please mark your calendars.

17 Item number 2 is the revised asset
18 allocation policy. So "Whereas" --

19 MR. DORSA: Can we please move to the
20 resolved?

21 MR. McTIGUE: Thank you, Mr. Dorsa.
22 "Resolved, that the Board of Trustees adopt
23 the attached asset allocation policy which
24 shall be incorporated into TRS's Investment
25 Policy Statement as Appendix 5; and be it

6 Statement to confirm that the asset allocation
7 continues to be appropriate in the context of

9 tolerances."
